Damage Protection (Included): Our Paul Effman Music Service Damage Protection Plan comes with every rental at no extra cost, covering accidental damage to your child's instrument. This doesn't include intentional misuse or blatant neglect (e.g., repeatedly striking an instrument with an object, vandalizing the instrument, etc), loss, or theft, so please keep it safe. Accessories like reeds, drumsticks, neck straps, and mouthpieces aren't covered—these are your responsibility to replace if damaged or lost. All repairs must be completed by Paul Effman Music.

No Refunds for Early Returns: If you return the instrument before June 30, 2026, there's no refund.

Lost Instruments: If an instrument is lost or stolen, you'll be responsible for the replacement cost (tax included): Alto Saxophones and Specialty Instruments: \$1,850; Bell Kit: \$500; All others: \$800.

Accessories like rosin, end-pin anchors, straps, shoulder rests, etc. aren't covered—these are your responsibility to replace if damaged or lost. String replacements are provided as a courtesy at our discretion for normal wear or accidental breakage. We reserve the right to track replacements and may deny service in cases of excessive or intentional damage. All repairs must be completed by Paul Effman Music.
